1. Review Bracken's additions to the scheduling policy r.e. scaffolding courses (attachment)

Committee members received the scheduling policy on Tuesday, August 6. The document had been edited to clarify policies related to scaffolding courses. Committee members discussed and approved the suggested changes. The changes are effective for Spring 2020 scheduling. Scheduling Policy goes out every quarter; the Registrar will emphasize the policy changes when sent out to departments.

Voting Results: All present committee members approved the new language included in the scheduling policy.

2. Review new pre-assignment request from BPSC (attachment)

The Committee received a request for BPSC 21 to be included in pre-assignment. This is a popular non-major course offered twice a year. An important special activity is they take all students on a tour of Ag Ops during class time. This must be done during business hours, as Ag Ops staff need to be present and daylight is needed. They also need 80 minutes, 60 minutes is not enough time.

i. Discussion items:

CNAS non-major courses are really impacted; these courses and this one in particular are planning to expand. Committee members supported the pedagogical justification but were concerned that this could be problematic if many other courses make similar requests. Committee members also expressed that the special activity should be a signature feature of the course.

Voting Results: All present committee members approved the Chair's proposal to support the request. If in the future there is influx of this type of requests, the committee will revisit this idea.
